

## **BOROUGH OF ROSE VALLEY**

### **ORDINANCE NUMBER 333**

**AN ORDINANCE OF THE BOROUGH OF ROSE VALLEY, DELAWARE COUNTY, PENNSYLVANIA, ADOPTING THE MOST STRINGENT COMBINATION OF DELAWARE COUNTY REGIONAL WATER QUALITY CONTROL AUTHORITY'S (DELCORA'S) STANDARDS, RULES AND REGULATIONS AS ROSE VALLEY BOROUGH'S WASTEWATER CONTROL REGULATIONS ; ADOPTING DELCORA'S WESTERN SERVICE AREA LOCAL LIMITATIONS AS THE LOCAL LIMITATIONS FOR ROSE VALLEY BOROUGH AND REPEALING ALL ORDINANCES , RESOLUTIONS AND PARTS THEREOF WHICH ARE INCONSISTENT HEREWITH.**

THE BOROUGH OF ROSE VALLEY HEREBY ORDAINS:

#### **SECTION 1. Purpose.**

This Ordinance is adopted to promote and protect the public health, safety, comfort, convenience and other aspects of the general welfare. These general goals include, among other things, the specific enforcement of the Clean Water Act and the Pennsylvania Clean Streams Law and the various regulations promulgated by DELCORA, the United States Environmental Protection Agency, the Pennsylvania Department of Environmental Protection, and their successors, and the implementation of the Delaware County Wastewater Management Plan and the National Pretreatment Standards, 40 C.F.R. 401, et seq.

#### **SECTION 2. Wastewater Treatment Regulations.**

The DELCORA Standards, Rules and Regulations of 2011, attached hereto as Exhibit "A," are hereby collectively adopted as the Wastewater Treatment Regulations for the Borough of Rose Valley.

#### **SECTION 3. Local Limitations.**

The DELCORA Local Limitations for the Eastern Service Area (the "Eastern Limitations") and the DELCORA Local Limitations for the Western Service Area (the "Western Limitations"), as set forth in DELCORA Resolution 2011-01, attached hereto as Exhibit "B," is hereby adopted as the Local Limitations for all discharges of wastewater on the Borough of Rose Valley. All such discharges of wastewater in the Borough of Rose Valley shall comply with the Western Limitations.

**SECTION 4. Repealer.**

All Ordinances, Resolutions, or parts thereof, inconsistent herewith are hereby repealed to the extent of such inconsistency.

**SECTION 5. Effective Date.**

This Ordinance shall become effective thirty (30) days after it is passed by Council, signed by the President of Council and Approved in writing by the Mayor.
